2016-2017 Enrollment and Staffing Projections (B2)

Mr. Hatcher reviewed the enrollment and staffing projections. He explained how the decrease in students from the FUESD is impacting and reflecting on us with our declining enrollment. As they continue to lose students it has a direct effect on us. He also shared that the number of interdistrict out of district requests have declined. The number of students choosing to leave the district via this request are lower. He reviewed the projection model and spoke about how this reflects on the staffing with a decline of 3.0 FTE reduction for next school year.


